Stewards accepted explanations from Trainers R Hall and R Carr for their late declaration of riders at today's race meeting

***** Following a track inspection by Stewards and jockeys, the track was downgraded to HEAVY (8) at 11.29 am *****

RACE 1 – RAINE & HORNE TAMAR VALLEY SUPEROBIS 3YO & UPWARDS MAIDEN – SET WEIGHTS – 1100 METRES - DIVISION 1

Power of Nature underwent a veterinary examination prior to the start of this race and was passed fit to take its place in the field.

Syzygy jumped awkwardly.

Miss Leni jumped away awkwardly and bumped with Round Saturn.

Apprentice J Riordan (Round Saturn) pleaded guilty to a charge under AR 137(a) careless riding in that soon after the start he allowed his mount to shift out when insufficiently clear of Don't Tell Susan who had to check and then lost its position. Apprentice Riordan's licence to ride in races was suspended for a period of two race meetings from midnight Sunday 8 November 2009 until midnight 15 November 2009.

Miss Leni raced greenly throughout.

A post race veterinary examination of Don't Tell Susan failed to reveal any abnormalities. Stewards advised Trainer C Goggin that Don't Tell Susan has been stood down to a satisfactory barrier trial due to its barrier manners and poor performance today.

RACE 2 – RAINE & HORNE SORELL SUPEROBIS 3YO & UPWARDS MAIDEN – SET WEIGHTS – 1100 METRES - DIVISION 2

Gold Tryst jumped away awkwardly.

Maradona and Fairlands Fancy bumped on jumping.

At approximately the 500 metres, Gold Tryst had to be momentarily steadied when racing to the inside of Maradona.

Fairlands Fancy laid in under pressure in the home straight.

Love Lace Princess laid in over the concluding stages.

A post-race veterinary examination of Gotacougar failed to reveal any abnormalities. Trainer Michael Luttrell was advised that Gotacougar must complete a satisfactory trial due to its poor performance today.

RACE 3 – RAINE & HORNE EASTERN SHORE MAIDEN / CLASS 1 PLATE – SET WEIGHTS – 1550 METRES

Green Crusader over raced in the early and middle stages.

Jockey E Brennen (Master Gee Gee) pleaded guilty under AR 137(A)(5)(a)(ii) in that he used the whip on three (3) additional occasions than the allowed five (5) times before the 100 metres. Jockey Brennen was fined the sum of \$200.

A post race veterinary examination of Desperate Times failed to reveal any abnormalities. Trainer John Blacker was advised that Desperate Times must complete a satisfactory trial due to its poor performance today.

RACE 4 – RAINE & HORNE KINGSTON 0-75 HANDICAP – 1550 METRES

Stewards granted permission for Jockey B McCoull to ride Breath Testa ½ kilogram over its allotted weight.

Stewards granted permission for Jockey L Coffey to ride Lemon Scene ½ kilogram over its allotted weight.

Himstedt was slow into stride.

At approximately the 700 metres Brief Interlude was briefly inconvenienced when Atcos Quest shifted ground inwards and Final Words shifted ground outwards.

Apprentice R Keogh stated that Our Magic Boy travelled well to the home turn but failed to respond when placed under pressure. A post race veterinary examination of Our Magic Boy failed to reveal any abnormalities.

RACE 5 – RAINE & HORNE HOBART CLASS 1 HANDICAP – 1100 METRES

Stewards granted permission for Jockey B McCoull to ride Liddlebit Flirty ½ kilogram over its allotted weight.

Sir Lugano was inconvenienced at the start between Lake Crescent who jumped outwards and Alibambi who jumped inwards.

Gee Gees Truce began to over race when being restrained by its rider from the 1100 metres to the 900 metres.

A post race veterinary examination of Alibambi revealed the mare to have a slow recovery rate. The mare was subsequently scoped by the veterinary surgeon and no abnormalities were detected. Trainer John Keys was advised that he must tender a veterinary certificate before Alibambi's next race start.

RACE 6 – RAINE & HORNE COMMERCIAL CLASS 2 HANDICAP – 1100 METRES

Ganoush was inconvenienced at the start when Curio jumped outwards and as a result was slow to begin.

Popular Quest was slow to begin.

Approaching the 700 metres, Champara began to momentarily over race.

At approximately the 500 metres, Matsematics who was shifting wider on the track to improve its position behind Curio bumped with Giveachickachance.

She's Good As Gold laid in under pressure in the home straight.

RACE 7 – RAINE & HORNE DEVONPORT 0-75 HANDICAP – 1100 METRES

Affair De Jour was fractious in the barriers and made contact with the top of its barrier stall. Affair de Jour underwent a veterinary examination and was passed fit to take its place in the field.

Operative, Cosmic Choice and Affair De Jour all bumped on jumping.

Affair De Jour raced erratically from approximately the 800 metres until the winning post. A post race veterinary examination of Affair De Jour revealed the gelding to be bleeding from a small cut behind his left ear.

At approximately the 500 metres Operative had to be steadied off heels when Cosmic Choice shifted in.
